SMU's SIDRA and ITI are pleased to jointly present this webinar on the Belt and Road Initiative: Maritime Silk Road. The Belt and Road Initiative (BRI) is a significant development strategy led by China, comprising of the Silk Road Economic Belt and 21st Century Maritime Silk Road. In 2013, Chinese President Xi Jinping proposed a revival of the ancient Maritime Silk Road. The aim of the 21st Century Maritime Silk Road is to deepen economic cooperation, social and cultural exchange through joint cooperation, in order to bring about increased development and prosperity of the countries along the Maritime Silk Road.

Mark McLaughlin, Incoming Global Visiting Assistant Professor at SMU, will introduce and orientate participants to the Maritime Silk Road. Punit Oza is a regular guest lecturer in SMU and a board member of Klaveness Asia. Together with Louisa Follis, Dry Cargo Senior Analyst at Clarksons Platou, they will provide their perspectives as seasoned shipping and maritime experts, on the commercial impact of the Maritime Silk Road on shipping routes and trade. The webinar will be moderated by Baldev Bhinder, a legal expert in the commodities sector.

Participants in the trading, commodities and maritime sectors will hear about how the interplay of geopolitical trends and the Maritime Silk Road has, and will, affect trade and business moving forward.

### About the Speakers



**Mark McLaughlin** is the incoming Global Visiting Assistant Professor at the Singapore Management University School of Law. His research focuses on dispute resolution, the Belt and Road Initiative, and international economic law. Mark has published articles on the Chinese approach to investor-state arbitration and the interaction between state-owned enterprises and mechanisms of dispute resolution. He holds an LL.B. from the University of Glasgow and a Ph.D. from the China University of Political Science and Law, where he was a lecturer in international investment law. Mark was awarded a Chinese Government Scholarship from 2016-2019.



**Punit Oza** sits on the board of Klaveness Asia Pte Ltd and is a guest lecturer at SMU-ITI on "Geopolitical Risks and their impact on shipping and trade flows". He is also the Executive Director and Registrar of the Singapore Chamber of Maritime Arbitration (SCMA).
